Sealed quotations/tenders are invited from interested reputed Local Travel Agencies/Tour Operators or private individuals for providing one nos. of Non AC/AC diesel driven TUV300/Bolero/Ertiga vehicle having sitting capacity 7 seated including driver, which shall conform to the terms & conditions (Annexure-II) for official use in Koraput Municipality office on monthly rent basis.

- 1. The Vehicle must be road worthy conditions, shall not be more than 3 years old from the date of initial registration & must have valid Regn. Certificate, Insurance Certificate, Fitness Certificate, valid contract carriage permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
- 2. The Driver of the vehicle must have a valid driving license for driving light transport passenger vehicle & should be sufficiently experienced in driving transport passenger vehicle.
- 3. The Driver should be well behaved, gentle & obedient in nature.
- 4. A sum of Rs. 5000/- shall be deposited S.D by the intending bidders in shape of D.D Bank Draft drawn in favour of the E.O, Koraput Municipality & submitted along with the tender as Security Deposit. After completion of the tender process, the amount will be refunded to unsuccessful bidders.

#### TERMS AND CONDITION FOR HIRING OF VEHICLES.

The following terms & conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

- The hired vehicles, during period of contract, shall have all necessary valid MV documents such as -Valid Registration Certificate, Pollution Certificate Renewal from Time to Time, Insurance Certificate, Fitness Certificate, valid contract carriage permit, proof of up to date tax payment etc. and D.L of driver available all the times. Koraput Municipality hiring the vehicle shall not be responsible for any damage /loss caused to hired vehicles or loss of life/injury made to any person or damage & any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.
  - The hired charges to be paid for monthly basis is final but does not include 2 cost of diesel, which is to be paid separately basing on actual consumption & lubricants as per existing Govt. norms. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricants, oil of engine, gear box & differential coolant, Tyres & Tubes, Battery etc. will be borne by the bidder.
    - It shall be the responsibility of the bidder to provide a good driver & the salary 3 of the driver shall be borne by the owner.
    - In case of breakdown for reasons whatsoever, the replacement of a vehicle of 4 the same or better model shall be provided by the owner of the vehicle /
    - In case of the vehicle do not report regularly, the authority will be liberty to 5 reject the agreement & may engage vehicle from other source. 6
    - The vehicle shall report for duty for minimum 26 days in a month. 7
    - In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded. 8
    - Monthly hire charges & reimbursements towards cost of diesel (as per actual) & lubricants (as per Govt-norms) of selected bidder will be paid in every succeeding month, as far as possible within 15 days of submission of bill by the service provider & no advance payment will be made. 9
    - The vehicle shall not be more than 3 years old from the initial Regn & also in good running conditions during the period of contract. 10
    - If the services are found to be unsatisfactory, the Client shall give one month 11
    - In case the service provider intends to withdraw the services of his vehicle & terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service & termination of agreement. 12
