- The Bid documents will be available in the website www.tenderorissa.gov.in from 11.00 A.M. On Dt. 20.01.2020 up to 5.00 P.M. on dt 04.02.2020 for online bidding.
- The Bidder must possess compatible Digital Signature Certificate (DSC) of Class II or Class III.
- Bids shall be received only "on line" on or before 5.00 P.M. Dt. 04.02.2020.
- The Original Documents only through Regd/Speed post should reach on or before 06.02.2020 up to 5.00 pm and other means of posting are not allowed.**
- Technical Bids received on line shall be opened at 03.00PM, on Dt. 07.02.2020** in the Office of the undersigned in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the Office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- After the date and time of receipt of bid is over, the original Bid security and Demand Draft/ Bankers Cheque / postal pledged towards cost of Bid documents shall be submitted in the Office of the undersigned on or before date and time of opening of Bid as specified at Para 06 above, during Office hours on working days failing which the bid will be rejected.
- The cost of bid documents in shape of demand draft/bankers cheque issued from / postal pledged and any Nationalized / Scheduled commercial Bank may be prepared in the name of the Executive Officer, Koraput Municipality mentioned under Col. 7 above payable at headquarter of Koraput Municipality separately i.e. towards paper cost of each Bid respectively.

- 10 Additional Performance Security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance security (APS) in shape of Demand Draft/Term Deposit Receipt pledged in favour of the Executive Officer within seven days otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further proceeding for blacklisting shall be initiated against bidder.
- 11 If the rate quote by the bidder is less than 15% of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalize the tender through a transparent lottery system, where all bidders /their authorised representatives, the concerned Executive Engineer and DAO will remain present.
- 12 Other details can be seen in the Bidding documents.
- 13 Any undertaking for any required documents should not be allowed, the tender will be rejected at the spot.
- 14 The estimated cost is included GST 12%.
- 15 Valid and upto date required document should be enclosed falling which the concerned tender paper of the Bidder will be canceled without any further correspondence.
- 16 The Authority reserves the right to cancel any or all the Bids without assigning any reasons thereof.

GENERAL CONDITION OF CONTRACT

01. Tenders are required to deposit 1% of the bid amount as earnest money in shape of Demand Draft in favour of Executive Officer, Koraput Municipality.
02. Additional Performance Security shall be deposited by the successful bidder when the bid amount is seriously unbalanced i.e. less than the estimated cost by more than 10% and in such an event, the successful bidder will deposit the Additional Performance Security to the extent of the differential cost of the bid amount in shape of bank draft/ bankers cheque from any Nationalised Bank in favour of Executive Officer, Koraput Municipality at the time of submission of tender. The APS shall be released after completion of the work to the satisfaction of authority and after completion of 12 calendar months.
03. The work is to be completed within the stipulated period as mentioned in the TCN.
04. Conditional tenders containing terms and conditions are liable for rejection.
05. The Contractor shall furnish a certificate along with tender to the effect that he is not related to any officer in the rank of an Assistant Engineer & above. If the fact subsequently proved to be false, the contract is liable to be rejected.
06. No escalation of cost in respect of labour, POL, material & other item. If any, will be entertained during the course of execution of work.
07. The tenders are required to furnish attested copies of valid PAN card & renewed registration of GST at the time of submission of tender document and originals of which are to be produced before date of opening.
08. Each tenderer is expected to inspect the site of the proposed work to know the exact working condition before tendering his offer.
09. The detail of work can be had in the office of the Executive Officer, Koraput Municipality during office hours on any working days. Relevant ISI standard PWD/ PHD specification of Government of Orissa is to be followed during course of execution.
10. On no account the contract work should be assigned or subject to sublet without prior approval of Koraput Municipality and in such event the contract may be rescinded by Executive Officer, by giving a notice in writing. The contractor should be duly liable in dimity to the Municipal for any compensation payable by Koraput Municipality to any quarter and in such case the same would be recovered from the Contractor.
11. The Contractors should abide by the fair wages clause notified by the Government in Labour Department and in force during the period of execution and shall not pay less than the fair wages fixed by Government to the labourer engaged by him for the work.

12. The tenderer whose tender is accepted forthwith. On written intimation being given to him about acceptance of tender, make requisite initial security deposit and sign the agreement within 7 days of such intimation for due fulfilment of contract in the office of the Executive Officer, Koraput Municipality, failing which it be liable for forfeitures of the earnest money.
13. The Lowest Tenderer shall submit **the quality test certificate report of materials** used in work as and when required.
14. The contractor will use **SAIL** rod (Steel) for the reinforcement work and 43 grade OPC cement for execution of the work.
15. The contractor should arrange at his own cost necessary T&P such as pump, vibrator, concrete mixer, scaffolding materials etc. as would be required during execution of work.
16. The department has the right to inspect the work and can reject partly or fully each structure if found defective in their opinion.
17. No claim for compensation for any damage caused by rain or any other natural calamities during the execution of work will be entertained.
18. All safety measures are to be taken by the contractor during the execution and till final completion of work by the contractor at his own cost.
19. Under no circumstances interest is chargeable to the contractor for the due or additional dues if any payable to him for the work.
20. All tender received will remain valid for period of 90 days from the date of receipt of tender.
21. Payment will be made subject to availability of funds.
