

## **ELIGIBILITY CRITERIA & GENERAL INSTRUCTIONS** **TO TENDERERS**

1. The technical bid shall be accompanied with attested photocopies of the following requisite documents failing which the bid shall be rejected out rightly.
2. Valid Regn. Certificate /Delaer Certificate / Manufacturing license etc. as applicable should be enclosed ( as specified in tender schedule).
3. Up to date GST Certificate.
4. EMD of Rs. 10,000.00 ( ten thousand)as specified in tender documents.
5. Cost of tender document as specified in tender schedule.
6. Income Tax clearance Certificate.



### GENERAL CONDITION

1. The bidders are expected to examine all the instruction, terms & conditions in the bid document. Failure to furnish all information as per the bid document & submission of bids not substantially responsive to bid document in every respect will be at bidders risk & shall result in rejection of the bid.
2. The bid is meant for supply of Sanitary Materials as specified in the tender Koraput Municipality shall have right to float any comprehensive bid during the contract period & no party will have right to challenge it.
3. Koraput Municipality shall have the right to terminate the contract on the ground of supply of poor quality materials.

5. Bids containing over writing / additions /alterations /erasers /obliteration & other discrepancies should be properly attested by them.
6. Letter of authorization for representing the Reg. firm etc. & to sign the bid document should be enclosed along with the bid document.
7. The bidder shall sign every page of the tender document & submit all of them.
8. The bidder should quote both in figures & words. Where ever, if there is difference between the rate quoted in figures & words, the rate quoted in words will be taken as correct.
